**Competition Site:** J.K. Northway Exposition Center (located at Dick Kleberg Park). The J.K. Northway is the large arena located at the park.



**Parking:** The J.K. Northway is a coliseum that seats over 6000 individuals, there will be plenty of parking at the event site.

- Reporting/Weigh-Ins:** Registration and weigh-ins will be conducted at the J.K. Northway Coliseum (Competition Site), from 8:00 a.m. To 11:00 a.m. on Friday the 16<sup>th</sup> of April. On Saturday and Sunday weigh-ins will be conducted at the host hotel (Super 8, 105 S. Hwy 77). Weigh-in times for Sat and Sun 7am SHARP. Athlete must weigh in each day that they compete.
- Forms:** All participants/teams must mail their required Forms to STABA, P.O. Box 200445, San Antonio, Tx 78220 to be postdated no later than April 9<sup>th</sup>, 2010. Suggestion: Bring a copy of your packet with you.
- Required Forms:** Boxers Official Entry Form

- Registration Fee:** There will be no registration fee for this tournament. STABA has paid for all of its athletes to compete free of charge.
- Physicals:** Friday 4:30 p.m. at The J.K. Northway Coliseum. Saturday and Sunday immediately following weigh-ins at the host hotel.
- USA Boxing Membership: Athlete Registration** All athletes must present passbook with a 2010 registration at the initial check in. NO BOOK NO BOX!
- Coaches Registration & Certification** All coaches must have their USA boxing membership card FY 2010 or pink copy and STABA certification Card. **IT WILL BE CHECKED**
- Credentials** Each team will receive the following amount of Coach's Passes (1-6 boxers = 2 passes) (7 or more = 3 passes) no More than 3 passes will be given per team. Passes will be given out during initial registration.

**Travel:** All participants must pay for their own travel, meals and lodging for this event. Recommend that participants stay at the host hotel due to special rate.

**Headquarters Hotel:** **The Super 8 Hotel (105 S. Hwy 77, 361-592-6471 will be the host hotel.** This hotel is offering a special rate of \$59.99 for a double bed room. Hotel also offers free Continental Breakfast. You must mention the USA Boxing Tournament to get rate.

**3 – 2 Minute Rounds**

**Minimum of five (5) bouts excluding walkovers.**

- Age Determination:** Age is based on the boxer's age as of 1 August 2010.
- Equipment:** Host will only provide competition gloves. All other Items, i.e. headgear, foul proof cups, form fitted Mouthpieces, competition uniforms, sponge, water Bottles, towels etc. must be provided by the participant Only USA Boxing Approved Headgears will be allowed.
- Attire:** Contestants must wear individually fitted mouthpieces, singlet, boxing trunks, flat soled boxing shoes, foul-proof cups and headgear during each bout.
- Protest:** A \$50.00 cash protest fee must accompany each written official protest. The fee will be returned if the protest is found to be valid.
- Admission:** VIP Tables Ringside (Seating 8 Individuals) - \$120.00
